1. **Bhajani Municipality, Office of Municipal Executives, Kailali** invites sealed bids or electronic bids from eligible bidders for the Construction of Bhajani Municipal Office Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the construction turnover and minimum work experience below should participate in this bidding:
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Bhajani Municipality, Kailali, Nepal**. or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp)
4. A complete set of Bidding Documents may be purchased from the office **Bhajani Municipality, Office of Municipal Executive, Kailali, Province no. 7, Nepal** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs 10000 till **08-08-2018 10:00 during office hours**.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .



5. Pre-bid meeting shall be held on 30-07-2018 at Bhajani Municipality, Office of Municipal Executive, Kailali on or before 2 P.M.
6. Sealed or electronic bids must be submitted to the office **Bhajani Municipality, Office of Municipal Executive, Kailali, Province no. 7, Nepal** by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **1200hrs on 09-08-2018**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1400 hrs. 09-08-2018** at the office of **Bhajani Municipality, Office of Municipal Executives, Kailali, Province no. 7, Nepal**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs 30,00,000**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
